A deadly motorcycle accident in Phelps County resulted in a settlement totaling \$4 million for the family of the couple in the crash.

Linda, were driving a 2006 Harley Davidson on a two-lane highway near St. James. In a lawsuit, the plaintiffs alleged that a treetrimming bucket truck in the oncoming lane made a sudden left-hand turn in front of the motorcycle.

The motorcycle collided with the bucket truck near the passenger door in a relatively low speed collision. Nonetheless, Linda Morrow was thrown underneath the right rear of the truck and was killed instantly. Gary Morrow struck the side of the truck and was Injured.

Linda Morrow's survivors filed a lawsuit in

October 2014 against Bakomax, the Osceolabased tree-trimming service, claiming the driver of the truck, Derek S. Robertson, had been negligent and that the company was vicariously liable.

According to court records, the defendants On June 26, 2014, Gary Morrow and his wife, had a \$1 million primary liability policy with EMC Insurance and a \$3 million excess policy through CNA Insurance. A.W. Smith, an attorney for Linda Morrow's two adult children, Michael Shields and Christina Scantlin, said the plaintiffs globally made several pre-suit demands to settle the claims for the policy limits. Over hie next 15 months, the parties engaged in discovery and depositions. Smith said the settlement was reached in November following the deposition of the bucket truck's driver. The case had been scheduled to go to trial in December.

Judge Jon Beetem, a Cole County circuit judge who was appointed to oversee the case, approved the wrongful death settlements on Dec. 31. according to court records.

Michael Hamlin, a Pitzer Snodgrass attorney representing the defendants, didn' return a call seeking comment.
